Petition praying that in the circumstances stated therein and in the petition filed therewith the High Court may be pleased to suspend the sentence imposed in S.C.No.51/2013 dated 19.09.2017 passed by the Honorable III Additional Sessions Judge and Special judge for PCR Act cases, Madurai and enlarge the petitioner on bail pending disposal of the Criminal Appeal.

Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.J.ANANDKUMAR, Advocate for the petitioner and of PUBLIC PROSECUTOR on behalf of the Respondent, the court made the following order:-

This petition has been filed by the petitioner to suspend the sentence imposed by the learned Additional Sessions Judge and Special Judge for PCR Act cases, Madurai in S.C.No.51 of 2013 dated 19.09.2017 and enlarge the petitioner on bail, pending disposal of the present Criminal Appeal.

2. Heard both sides.

3. Considering the facts and circumstances of the case and upon hearing the learned counsel appearing for both sides, this Court is of the view that the petitioner could be granted the relief as prayed for with certain conditions.

4. Accordingly, the petitioner are ordered to be enlarged on bail on executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for a like sum to the satisfaction of the III Additional Sessions Judge and Special Judge for PCR Act cases, Madurai and on further condition that the



petitioner should report before the said Magistrate, on the first working day of every English calendar month at 10.30 a.m., until further orders.
