Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.D.RAMESHKUMAR, Advocate for the petitioner and of Government Advocate (Crl.side) on behalf of the Respondent the court made the following order:-

This petition has been filed by the petitioner to suspend the sentence imposed by the learned Additional Sessions Judge, Karur in Spl.S.C.No.2 of 2017 dated 25.09.2017 and enlarge the petitioner on bail, pending disposal of the present Criminal Appeal.

2. Heard both sides.

3. Considering the facts and circumstances of the case and upon hearing the learned counsel appearing for both sides, this Court is of the view that the petitioner could be granted the relief as prayed for with certain conditions.

4. Accordingly, the petitioner is ordered to be enlarged on bail on executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for a like sum to the



satisfaction of the Judicial Magistrate No.1, Karur and on further condition that the petitioner should report before the said Magistrate, on the first working day of every English calendar month at 10.30 a.m., until further orders.
