2. Heard the learned counsel appearing for the petitioner as well as the learned Government Advocate (Cr1.side) appearing for the first respondent.

3. During the pendency of the proceedings, at the intervention of the of the Mediators and the Jamath elders, an amicable settlement has been arrived at between the parties. An affidavit has been filed by the de-facto complainant. In the said affidavit, the defacto complainant/second respondent has stated that the dispute has been amicably settled and he has no objection
