PRAYER IN CMA(MD) No.SR41094 of 2016

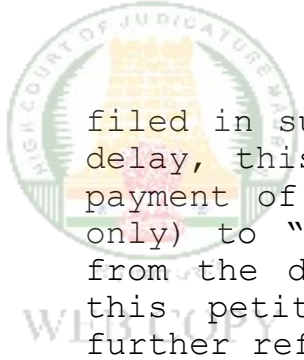
