PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

Heard both sides.

2.The petitioner, who was arrested on 14.02.2018 for the alleged offences punishable under Sections 397 and 506(ii) IPC, in Crime No.1727 of 2005 on the file of the respondent police, seeks bail.

3.The learned counsel for the petitioner submitted that non appearance of the petitioner is neither wanton nor willing.

4.The learned Additional Public Prosecutor submitted that since the accused has not complied with the condition imposed while granting bail, Non Bailable Warrant came to be issued.

5.Considering the facts and circumstances of the case and also taking note of the period of incarceration of the petitioner, I am of the view that the petitioner could be enlarged on bail. It is made clear that the petitioner shall appear for all the future hearing without fail to the best of his ability. Accordingly, it is ordered that the petitioner shall be released on bail, on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a likesum to the satisfaction of the learned Judicial Magistrate IV, Madurai and on further condition that the petitioner shall report before the respondent police daily at 10.30



a.m. for a period of two weeks and thereafter, as and when required for interrogation.
