PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner apprehends arrest at the hands of the respondent police for the alleged offences under Sections 294(b), 336, 324 and 506(i) of IPC in Crime No.34 of 2018 and seeks anticipatory bail.

2.The case of the prosecution is that the petitioner and his friends came to defacto complainant's shop and took the soda pottle and thrown inside the petty shop. When the same was questioned by the defacto complainant, the petitioner and his friend attacked the defacto complainant and caused injury.

3.The learned counsel for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case.

4.The learned Government Advocate (Crl.side) submitted that injured has been discharged from the hospital.

5.Considering the facts and circumstances of the case and taking note of the fact that injured has been discharged from the hospital, this Court is inclined to grant the relief of anticipatory bail to the petitioner. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his



appearance before the learned Magistrate concerned within a period of 10 days from the date of receipt of a copy of this order, on his executing a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Kamuthi, Ramanathapuram District or to the satisfaction of the respondent police or the police officer who intends to arrest and on further condition that the petitioner shall appear before the respondent police daily at 10.30 a.m., until further orders.
