PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

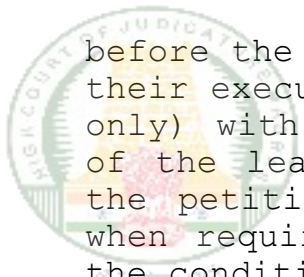
ORDER : The Court Made the following order :-

The petitioners are apprehending arrest at the hands of the respondent police for the offences punishable under Sections 147, 148, 294(b), 324 & 506(2) of Indian Penal Code in Crime No.238 of 2018, seek anticipatory bail.

2.It is seen from the contents of the First Information Report, on 19.05.2018 in Trichy Airport premises, there was scuffle between the two political parties.

4.Heard the learned Government Advocate (Crl. side).

5.This Court is of the view that custodial interrogation will not be necessary for carrying the investigation. Therefore, this Court is inclined to grant anticipatory bail to the petitioners with certain conditions. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance



before the learned Judicial Magistrate No.6, Trichy District and on their executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two common sureties for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that the petitioners shall appear before the respondent police as and when required for interrogation. The petitioners shall comply with the conditions stipulated under Section 438 Cr.P.C. scrupulously.

6.The petitioners shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy is made ready, failing which, the petition for anticipatory bail shall stand dismissed.
