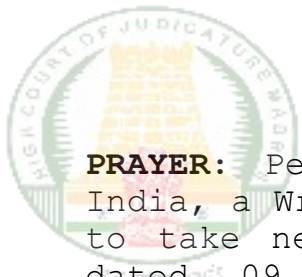

4.The writ petition is disposed of with the above directions. No costs.

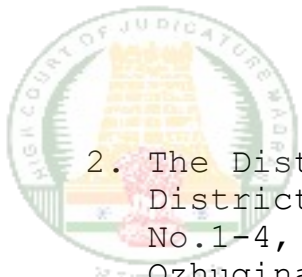
