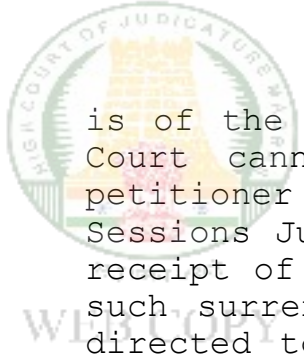
O R D E R

is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the learned District and Sessions Judge, Karur within a period of two weeks from the date of receipt of a copy of this order and file a petition for bail and on such surrender, the learned District and Sessions Judge, Karur is directed to consider the bail petition filed by the petitioner in connection with the Crime No.98 of 2018, on the same day, on merits and in accordance with law, after issuing notice to the de-facto complainant/victim under Section 15 (A) of the SC/ST Act.

4. With the above direction, this Criminal Original Petition is disposed of.
