2.On 10.10.2018, in Crl.O.P(MD)No.17667 of 2018, the petitioner was granted bail in Cr.No.37 of 2018, which had been registered by the Inspector of Police, Kovilankulam Police Station, Ramanathapuram District, under Sections 147, 148 and 302 of IPC. The application for modification of bail has been filed by the petitioner, who states that the petitioner would facing life threat, if he appeared before



the respondent police and prays to appear before the Sivagangai Town Police Station. It is further stated that two other accused had been granted bail and are also appearing before the Sivagangai Town Police Station.
