**ORDER**

This petition is filed seeking a direction to the 2<sup>nd</sup> respondent to register a case based on the complaint given by the petitioner dated 04.04.2018.

2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents.

3. The learned counsel for the petitioner would submit that the 2<sup>nd</sup> respondent police has not registered a case against the proposed accused for the offence with regard to bigamy.

4. Per contra, the learned Additional Public Prosecutor on instructions, would submit that the dispute between the parties is purely family dispute. Therefore the complaint has to be referred to the Social Welfare Officer and after obtaining report from the Social Welfare Officer, the respondent police will take



further action in the above said complaint in accordance with law.

5. At this stage, the learned counsel for the petitioner seeks liberty to approach this Court at a later stage, if necessary.
