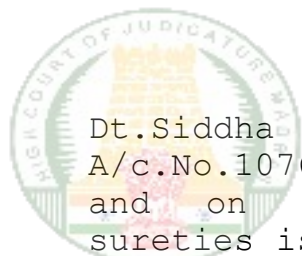

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. side) appearing for the respondent.

3.It is seen that there was a delay of 14 days to execute the sureties and surrender before the Trial Court by the petitioner.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the petitioners shall deposit a sum of Rs.1,000 (Rupees one thousand only) to the credit of
