in the representation as he is the President of the Festival Committee of the temple. The petitioner made his representation to the respondents as an individual capacity. Therefore, the prayer sought for by the petitioner in this writ petition cannot be granted. Hence, the writ petition is liable to be dismissed as not maintainable.

4. In the result, this writ petition is dismissed as not maintainable. No costs. However, liberty is given to the concerned President or organizer or representative of the Festival Committee to make a fresh representation to the respondents, if so advised.
