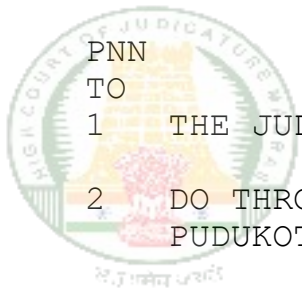
2.The learned counsel for the petitioner seeks this Court, to produce common sureties before the Learned Judicial Magistrate, Aranthangi.
