ORDER

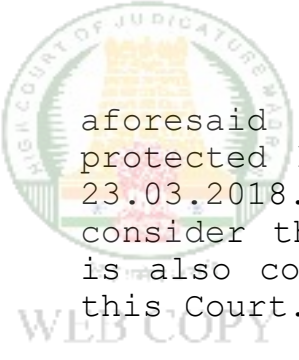

3.In an earlier Writ Petition in W.P.(MD)No.6347 of 2018, the Hon'ble Division Bench of this Court, by an order dated 23.03.2018, had directed the official respondents therein to take action on the alleged encroachers in Survey No.89/1 situated in Boothamangalam Village, Melur Taluk. While observing so, the Hon'ble Division Bench of this Court had also directed the official respondents to give due opportunity to the private respondents impleaded in that writ petition, who are alleged to have been encroachers.
