PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner / accused no.8 apprehends arrest at the hands of the respondent Police for the offences under Sections 147, 148, 302 of I.P.C. r/w. 3(1)(r)(s), 3(2)(va) Scheduled Castes / Scheduled Tribes Act @ 147, 148, 302, 120 (b) of I.P.C r/w. 3(1)(r) 3(1)(s) and 3(2)(V) of Scheduled Castes / Scheduled Tribes (POA) Act in Crime No.201 of 2017 and seeks anticipatory bail.

2.Taking note of the nature of the allegations made against the petitioner, the petitioner is permitted to surrender before the learned Jurisdictional Special Court within a period of two weeks from the date of receipt of a copy of this order.

3.The petitioner shall notify the *de facto* complainant with regard to the exact date of surrender through registered post. This communication shall be sent at-least one week in advance before the date of surrender. Service of such notice will be taken as service on the *de facto* complainant for the purpose of statute.

4.On such surrender by the petitioner and his application for regular bail, the Jurisdictional Special Court is directed to consider the bail application and dispose of the same on the same day.



5. With these observations and directions, this Criminal Original Petition is disposed of.
