2.This Court while granting bail to the petitioners, directed them to pay a sum of Rs.50,000/- together. The learned counsel for the petitioners submits that the petitioners are poor persons and therefore they are not in a position to deposit the said amount.



3.It is now submitted that charge sheet has also been filed.
