ORDER

This Criminal Original Petition is filed to direct the second respondent to register a case based on the petitioner's complaint dated 09.05.2018 and to investigate the case in accordance with law.

2. Heard the learned Counsel for the petitioner and Mr.K.Suyambulinga Bharathi, learned Government Advocate (Crl. side), who takes notice for the respondents.

3. The learned Government Advocate (Crl. side) would submit that the petitioner is not appearing before the respondents police and not co-operating for the investigation. He would further submit that if the petitioner appears for the enquiry and produces the relevant documents to prove his ownership over the vehicle, then the respondents police will take note of the same and proceed further in the manner known to law.

4. At this juncture, the learned Counsel appearing for the petitioner undertakes that the petitioner will co-operate for the enquiry by appearing before the respondents police, as and when he is called for by the authorities by issuing appropriate notices.
