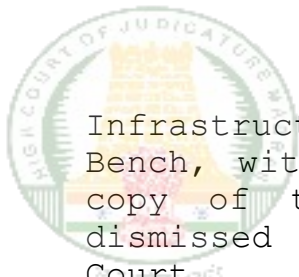
PRAYER IN CMA(MD) No.SR37871 of 2017:
