To Stay the order passed by this Honourable Court in Crl.O.P.(MD).No.8240/2018 dated 23/05/2018.

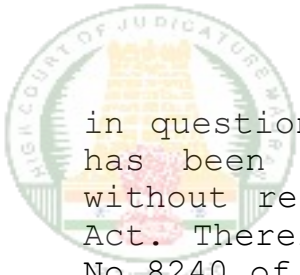

Bail has been granted on 23.05.2018 in CrI.O.P(MD).No.8240 of 2018, without recording any satisfaction in terms of Section 37 of NDPS Act. Therefore, the bail granted to the petitioner in CrI.O.P(MD).No.8240 of 2018 is illegal and the same stands cancelled.
