The prayer in this writ petition is to quash the communication dated 08.09.2014 issued by the respondent/Nagercoil Local Planning Authority.

2.All that the writ petitioner states is that the petitioner was not justified in putting up construction even without getting prior permission and approval of the statutory authority. The impugned communication further states that in view of the order made in W.P.(MD) No.13838 of 2014, it is not possible to consider the resubmitted application filed by the writ petitioner.



3. Since this Court had already directed the respondent to consider the resubmitted application, no further orders are necessary in this matter. There is nothing in the impugned order that warrants any interference.
