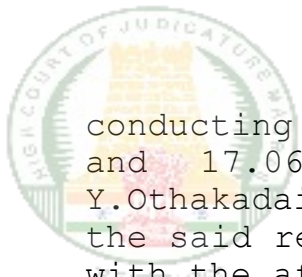
ORDER

3.According to the petitioner, he made a representation dated 11.06.2018 to the respondents to grant permission and protection for



conducting the ''Gandhi Nagar Cricket Tournament'' on 16.06.2018 and 17.06.2018 in the public playground at Gandhi Nagar, Y.Othakadai, Madurai District. Since no order has been passed in the said representation, the petitioner has filed this Writ Petition with the aforesaid prayer.

4.The learned Additional Government Pleader appearing for the respondents submitted that the petitioner's representation is still pending with the second respondent. Therefore, this Court may pass appropriate orders to consider the petitioner's representation on merits and in accordance with law.

5.Considering the submission made by both parties, without going into the merits of the case, this Court directs the second respondent to consider the petitioner's representation dated 11.06.2018 and pass appropriate orders on merits and in accordance with law on or before 15.06.2018. The petitioner shall submit a copy of a representation dated 11.06.2018 along with a copy of this order to the second respondent.

6.This Writ Petition is disposed of with the above direction. No costs.
