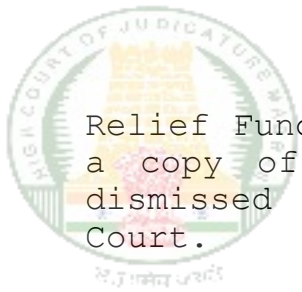
PRAYER IN CMA(MD) No.SR41864 of 2017:
