PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners are accused Nos.2 and 3. They were arrested and remanded to judicial custody on 21.04.2018 for the offences punishable under Sections 294(b), 324, 307 and 506(ii) of IPC in Crime No.100 of 2018, on the file of the respondent police. They seek bail.

2.The petitioners are in custody since 21.04.2018 for offences under Sections 294(b), 324, 307 and 506(ii) of IPC. The injured in this case has been discharged from the hospital.

3. Considering the said fact, this Court is inclined to grant bail to the petitioners with certain conditions. Accordingly, the petitioners are ordered to be released on bail, subject to the following conditions;

(i) the petitioners shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate No.2, Kumbakonam, Thanjavur District;



(iii) on breach of any of the aforesaid conditions, the Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005) AIR SCW 5560].
