The respondents 2 and 3 in this petition namely, Rani and Murugaiah are shown as accused Nos.3 and 4 in Crime No.19 of 2017, registered on the file of the District Crime Branch, Pudukkottai. They were granted with Bail by the learned Judicial Magistrate, Alangudi. To cancel the same, the petitioner herein had filed Crl.O.P.(MD)No.14034 of 2017. When the matter was taken up hearing, it had been undertaken by the said respondents that, they shall deposit a sum of Rs.10 lakhs to the credit of Crime No.19 of 2017 before the learned Judicial Magistrate, Alangudi on or before



2. It is now seen that the said condition has not been complied with till date. Extension of time has not been obtained. Hence, this Court has no other option other than to cancel the anticipatory bail granted in favour of the respondents 2 and 3 herein.

3. Accordingly, this Criminal Miscellaneous Petition is allowed.
