The petitioner, alleging wrongful encroachment by the fourth respondent of Survey No.674/18, situated at Ayyanar Kovil Street, Punjai Sankethi Village, Lalgudi Taluk, Trichy District, has sought consideration of his representation dated 29.11.2017.

2. It is brought to the notice of this Court that the second respondent had, under proceedings in O.Mu.A2-2923/2017, dated



28.12.2017, required the third respondent to conduct an enquiry into the matter. The learned Additional Government Pleader for the respondents 1 to 3 submits that the fourth respondent has been in enjoyment and use of the said site classified as "Grama Natham" over a period of 25 years.

3. In the light of the above, the Writ Petition shall stand disposed of with a direction to the third respondent to carry out the instructions given in the communication of the second respondent dated 28.12.2017, within a period of four weeks from the date of receipt of a copy of this order and the outcome of the representation of the petitioner shall be intimated to him. No costs.
