PRAYER IN CRP(MD) No.1846 of 2017:

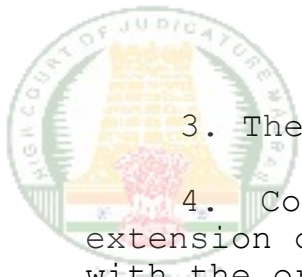
