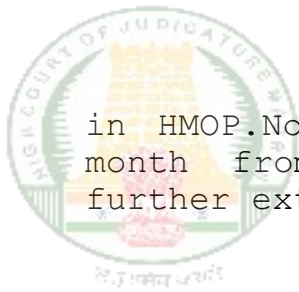
This petition has been listed today for extension of time for disposing the application in I.A.No.232 of 2016 in HMOP.No.351 of 2010, on the file of the Family Court, Madurai.

2. This Court has already disposed of the Civil Revision Petition by order dated 13.11.2017, directing the trial Court to dispose of I.A.No.232 of 2016 in HMOP.No.351 of 2010, within a period of four weeks from the date of receipt of a copy of this order. There was a request from the learned trial Judge on 15.12.2017, 28.03.2018 for extension of time and the same was granted. Now, the learned Judge has again sought for further three months time. Hence, the matter was listed today.

3. Considering the averments made by the Court below, this Court is inclined to extend time further.
