PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner apprehends arrest at the hands of the respondent police for the offences punishable under Sections 392, 397 and 506 (ii) of I.P.C. in Crime No.246 of 2012 and seeks anticipatory bail.

2.The petitioner is facing trial in S.C.No.341 of 2015 on the file of the 1st Additional Sub Court, Madurai. Non-Bailable Warrant issued against him on account of his absent on 13.06.2016.

3.The learned counsel appearing for the petitioner submitted that the petitioner had gone to Kerala for coolie works and in view of his poverty, he could not appear. The learned counsel further undertakes that the petitioner shall regularly appear on all future hearing dates and if he is not able to attend, the proper application under Section 317 Cr.P.C would be filed for condoning his absence. If these conditions are breached, this order would stand automatically cancelled.

4.Recording the undertaking given by the learned counsel appearing for the petitioner, the petitioner is permitted to appear before the 1st Additional Sub Court, Madurai, on the next hearing



date and apply for recall of warrant. On filing of such application, the 1st Additional Sub Court, Madurai is directed to recall the Non Bailable Warrant on the same date.

5. This Criminal Original Petition is allowed accordingly.
