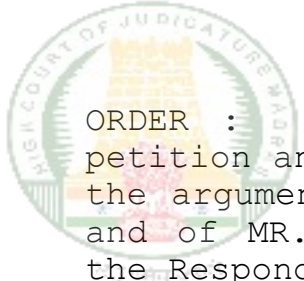
Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to grant a direction directing the respondent to release all the boats bearing provisional licence number IND-TN-12-MM-01 to 14, IND-TN-12-MM-17 to 19, IND-TN-12-MM-21 to 26, IND-TN-12-MM-29 to 34, IND-TN-12-MM-38, IND-TN-12-MM-40, IND-TN-12-MM-42, IND-TN-12-MM-43, IND-TN-12-MM-45 to 48 and IND-TN-12-MM-50 (37 BOATS) impounded by the respondent, pending disposal of the writ petition.

Prayer in WMP(MD). 19710/ 2018 in WP(MD). 21370/ 2018 :

To grant an INTERIM INJUNCTION restraining the respondents from preventing the members of the petitioner association from going for fishing, returning and berthing their boats in their respective port pending disposal of the writ petition

Prayer in WP(MD). 21370/ 2018 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Certiorarified Mandamus calling for the records relating to the impugned ANNEXURE attached with the provisional certificate of registration dated 27.09.2018 issued by the respondent and quash the same as illegal and consequently amend the same according to the merchant shipping rules.
