Mr.N.Shanmuga Selvam, learned Additional Government Pleader takes notice for the respondents 1 to 3.

2. By consent of both parties, this writ petition is taken up for final disposal at the stage of admission itself.

3. The petitioner seeks a direction to the respondents to ~~cancel the joint patta issued along with the fourth respondent and~~ for a separate patta in respect of the land in S.F.No.569/3A in Nallampillai Village, Manapparai Taluk. Therefore, he filed a



petition before the third respondent. In respect of his petition, the third respondent Thasildar has issued a notice for personal hearing on 08.09.2017. Till date, orders have not been passed. Aggrieved over the long pendency of the enquiry, the petitioner is before this Court.
