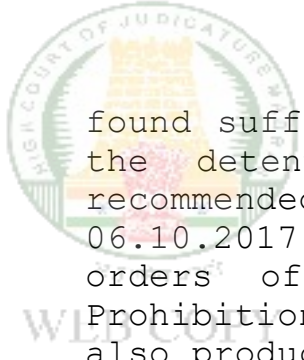

found sufficient grounds for revocation of the Detention Order of the detenu, namely Malaichamy and the Advisory Board had recommended for revocation of the order of detention dated 06.10.2017. Accordingly, the Government itself has revoked the orders of detention by the order in G.O.Rt.No.5864, Home, Prohibition & Excise (XIII) Department, dated 12.12.2017. He has also produced the copy of the said Government Order.
