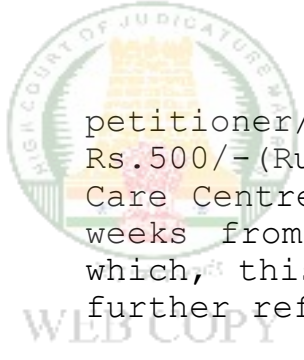
This petition is filed to condone the delay of 250 day in filing /re-presenting the above said appeal.
