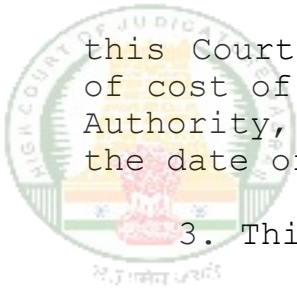
PRAYER IN CMA(MD) No.SR20813 of 2017:
