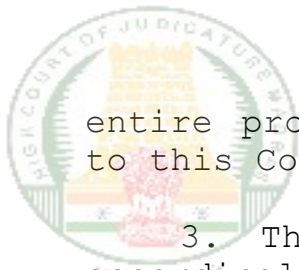

ORDER

The Registry received a Letter from one K.Balasubramaniam who is the fourth defendant and the petitioner in E.P.No.86 of 2008 on the file of the District Munsif Court, Palani. His letter is taken as a *Suo motu* Civil Revision petition. He had earlier filed C.R.P. (MD) No.2399 of 2017 for striking off E.A.No.135 of 2017 in E.P.No.86 of 2008 in O.S.No.53 of 1977. This Court by Order dated 14.12.2017 had allowed the Civil Revision petition and struck off the E.A.No.135 of 2017.
