PRAYER IN CMA(MD)No.SR16332 of 2018:-

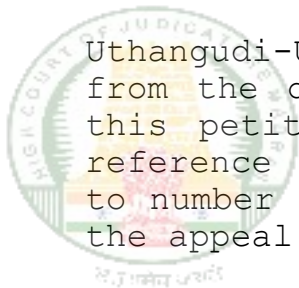
