Heard the learned counsel for the petitioner.

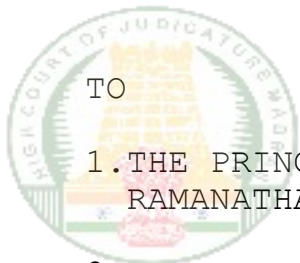
I am satisfied with the reasons stated in the affidavit filed in support of this petition.
