The petitioner, wife of the detenu, challenges the impugned order of detention dated 05.10.2018 passed in Detention Order No.2/2018(CS) detaining him as "Black Marketeer", as contemplated under the Tamil Nadu Prevention of Black Marketing and Maintenance of Supplies of Essential Commodities Act, 1980 (Central Act 7 of 1980) .
