The writ petition has been filed for issuance of a Writ of Mandamus directing the respondents to grant permission and to provide police protection to conduct the 'Aadalum Paadalum' cultural programme on 25.06.2018 in pursuant to the Aani festival of Arulmigu Sree Vinayagan - Sree Karuppasamy - Sree Mariamman & Sree Uthirakaliyamman Thirukovil, situated at Pampattipatty Village, Manapparai Taluk, Trichy District by considering the petitioner's representation, dated 23.06.2018.

2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents.
