The petitioner, who is stated to be a resident of Uthamaraseeli Village, Srirangam Taluk, Trichy District, has submitted a representation dated 26.03.2018, before the respondents with a request to repair the wheels of the chariot at Arulmighu Jambugheshwarar Akilandeshwari Temple, Thiruvanaikovil, Trichy. The said representation, till date, remains unanswered.

3. We have heard the learned counsel appearing for the petitioner, the learned Additional Government Pleader appearing for the respondents 1 to 3 and 5 to 7 and the learned Standing Counsel appearing for the fourth respondent.

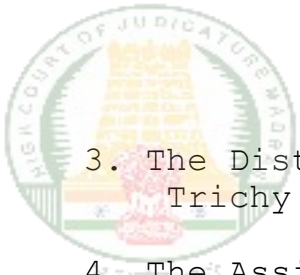
