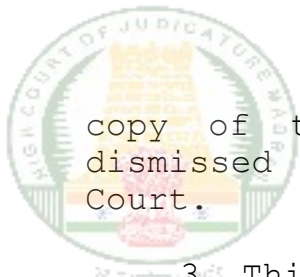
PRAYER IN CMA(MD) No.SR37780 of 2017:
