ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in C.C.No.240 of 2002 on the file of the learned Judicial Magistrate Court No.II, Thanjavur for the offences punishable under Sections 420, 468, 437 I.P.C r/w 7(1) A(ii) of E.C. Act, 1955 seeks anticipatory bail.

The concerned Judge is directed to consider the same on merits and pass orders on the same day.
