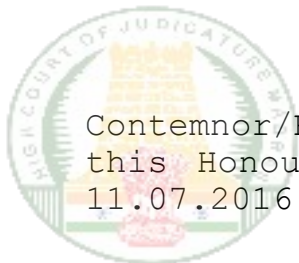
Prayer in SUB A(MD).Nos.214 and 215/2017 :

Contempt Petitions are filed under section 11 of Contempt of Courts Act, 1971, praying this Hon'ble Court to punish the



Contemnor/Respondent for the disobedience of the order passed by this Honourable Court in WP(MD)Nos.16128 and 16129 of 2015, dated 11.07.2016.

Prayer in WP(MD). 16128/2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the first respondent to issue patta to the petitioners for the land measuring Western 1 Acre 33 Cents in Survey No.28/4B and Survey No.28 / 4C1, Thathaneri Village, Madurai North Taluk, Madurai District and to pass such other and further orders as this Honble Court.

Prayer in WP(MD). 16129/2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus or any other appropriate Writ or order or direction in the nature of Writ directing the first respondent to issue a patta to the petitioners for the land measuring Eastern 40 Cents in Survey No. 28/4b and Survey No. 28/4C1, Thathaneri Vilalage, Madurai North Taluk, Madurai District.

Prayer in SUB A(MD).47 and 48/2018 :

Sub Applications are filed under section 151 of Civil Procedure Code, praying this Hon'ble Court to pass an order impleading the second respondent/proposed party as second respondent in Sub Application(MD) Nos.214 and 215 of 2017.

ORDER: These Petitions coming on for hearing on this day, upon perusing the affidavit and material papers filed, and upon hearing the arguments of Mr.T.R.Jeyapalam, Advocate for the Petitioner (In all Petitions), and of Mr.A.Thiagarajan, Government Advocate on behalf of the Respondents, this Court made the following Order:-
