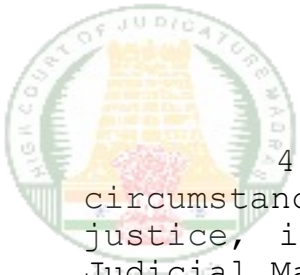

ORDER

This Criminal Original Petition has been filed praying to direct the learned Judicial Magistrate, Thiruppathur to expedite the trial in C.C.No.132/2016 within a stipulated period.

2.The learned counsel appearing for the petitioner would submit that the respondent police has registered a case in Cr.No.67 of 2016 against the petitioner and thereafter, investigation was completed and charge sheet has been filed before the learned District Munsif-cum-Judicial Magistrate, Thiruppathur and the same was taken on file in C.C.No.132 of 2016 and the same is pending for more than two years. In the circumstances, the petitioner has come out with the present Criminal Original Petition for speedy disposal of C.C.No.132 of 2016.
