2.Heard the learned counsel for the appellants and the learned Additional Government Pleader appearing for the respondents 2 to 7.

3.It is represented by both sides that as against the very same order passed by the Writ Court, another Writ Appeal in W.A(MD) No.1052 of 2017 was filed and the same was disposed of on 11.10.2017. The said Writ Appeal was filed by the respondents 1 to 6 in the Writ Petition. The Division Bench of this Court allowed the said Writ Appeal and set aside the order passed by the Writ Court. Therefore, the present Writ Appeal filed by the respondents 7 to 13 is also disposed of in terms of the order already passed in W.A(MD) No.1052 of 2017, dated 11.10.2017
