Therefore, Crl.M.P(MD).No.5031 of 2018 is allowed and the condition already imposed on the petitioner is modified to the effect that the petitioner is directed to deposit a sum of Rs.25,000/-(Rupees twenty five thousand only) to the Credit of Crime No.2 of 2018 before the lower Court.
