PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners are in judicial custody since 06.06.2018 for the offence punishable under Section 364(A) I.P.C in Crime No.364 of 2018 on the file of the respondent police. They seek bail.

2.Heard the learned counsel for the petitioners and the learned Government Advocate(Crl.Side) for the respondent.

3.The petitioners are said to have advanced a loan amount to the husband of the defacto complainant. Since the borrower did not repay the amount, he has been abducted. The petitioners are not having any previous case. The victim is also secured.

4.Taking note of the facts and circumstances, this Court is inclined to grant bail to the petitioners. Accordingly, the Petitioners are ordered to be released on bail, subject to the following conditions;

(i) the Petitioners shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only) each with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate, Ottanchathiram, Dindigul.



(ii) the Petitioners are directed to appear before the respondent police as and when required for interrogation.

(iii) the Petitioners shall not abscond.

(iv) on breach of any of the aforesaid conditions, the Magistrate/Trial Court is entitled to take appropriate action against the Petitioners in accordance with law as if the conditions have been imposed and the Petitioners are released on bail by the Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005) AIR SCW 5560].
