According to the learned counsel for the petitioners , the respondent has deposited a sum of Rs.56,000/- (Rupees Fifty Six thousand only) to the credit of M.C. 35 of 2016 on the file of the learned Chief Judicial Magistrate, Thanjavur at Kumbakonam, pursuant to the order, passed by this Court, dated 28.02.2018 in Crl.O.P.(MD) No. 2983 of 2018 and filed the present petition to withdraw the said amount.

2. The learned counsel for the respondent has no objection in allowing the said application.

3. In the light of the above observation, this Court direct the petitioners to withdraw the said amount, which is deposited before the learned Chief Judicial Magistrate, Thanjavur at Kumbakonam in M.C. No. 35 of 2016 after filing formal application before the Court.
