Considering the limited scope of the prayer sought for by the petitioner in the present Writ Petition, without going into the merits of the case, a direction is given to the third respondent to consider and dispose of the representation made by the petitioner dated 19.04.2018 on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.

6. The Writ Petition is disposed of with the above direction. No costs.
