### **O R D E R**

This Writ Petition has been filed to direct the third respondent to grant permission based on petitioner representation dated 29.05.2018 to conduct the Bharat Perunthalaiva Kamarajar birthday along with Light Music Performance on 15.07.2018 at Parankundrapuram Village, in V.K.Pudur Taluk of Tirunelveli District.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate appearing for the respondents.

3.According to the petitioner, the petitioner has made a representation to the second respondent on 29.05.2018 seeking permission to conduct the birthday of Bharat Perunthalaiva Kamarajar along with Light Music Performance on 15.07.2018 at Parankundrapuram Village, in V.K.Pudur Taluk of Tirunelveli



District. The said representation of the petitioner has not been considered so far. Hence, the petitioner is before this Court with the aforesaid prayer.
